Dr. Deborah Thomas-Austin is the Managing Director of the East Port of Spain Development Company, a special purpose State Enterprise established by the Government of Trinidad and Tobago, a position she has held since the Company became operational in 2006. Previously, she served as the Assistant Coordinator and Town Planner with the Town and Country Planning Division of the Government of Trinidad and Tobago from 2003 to March 2006. She holds a BA (Hons) in Planning Studies and an MSc in Urban Planning from Oxford Polytechnic (now Oxford Brookes University), UK, and a PhD in Land Economy from the University of Cambridge (Wolfson College), UK.

Dr. Thomas-Austin served as a part-time lecturer on the MSc Planning and Development programme in the Department of Surveying and Land Information at the University of the West Indies, Trinidad from 2002 to 2016 and for the past five (5) years has also lectured in Land Use Planning on the MSc programme in Occupational and Environmental Safety and Health in the Department of Chemistry at UWI St. Augustine. She is a former President of the Trinidad and Tobago Society of Planners. Dr. Thomas has consulted for the United Nations Development Programme/United Nations Centre for Human Settlements as a land use planner/project manager, working with the governments of Anguilla, Montserrat and Antigua and Barbuda between 1992 and 2001. She has also provided consultancy services to the Organisation of American States in the field of hazard mitigation in the Caribbean and participated in designing a hazard risk management course for the Caribbean Development Bank. Dr. Thomas is also a voluntary, trained tutor with the Adult Literacy Tutors Association of Trinidad and Tobago (ALTA) for the past nine (9) years. Dr. Thomas served for two terms from 2011-2019 as President of the World YWCA (a global movement of women and girls with a presence in over 125 countries advocating for, defending and promoting women's rights, leadership and empowerment and working for justice, peace, health, human dignity, freedom and the environment)

Topic 4: Experience working in Dharavi Slum

Abhijeet is the founder & Curator of DHARAVI RELOADED, which is India's most-loved junk percussion band, consisting of kids from the slums of Dharavi (one of the largest slums in Asia).

His knowledge imparting methods are exemplary, wherein he teaches music, in a way that it helps all the children recognize their talent quotient. He is of the belief, that this learning tool will inculcate discipline and help kids in finding livelihood opportunities in the future.

This unique band creates music from waste material found in the slums of Dharavi, such as drum barrels, coffee shakers, paint cans, plastic boxes and a lot more, bringing to the fore the concept of Recycle, Reuse & Respect. The initiative aims to enrich these kids' lives, while also aspiring to create a bond between communities.

The band has done more than 300 shows across India and has collaborated with some of the biggest artists and celebrities in the country. This project has helped children get recognized in their community, get rid of all their bad habits and most importantly it has made them financially independent, where they support their families and pay their own school fees.

Abhijeet has given several talks on various platforms about his project Dharavi Reloaded. Recently, he was in the U.S for a professional fellowship program where he spoke at various organisations, public/ private schools, and colleges.
